



STEM OPT Based on Prior Degree USCIS Application Checklist for e-Filing

This is a checklist of the evidence/documents an F-1 Student applying for STEM OPT is required to **UPLOAD** via the USCIS I-765 [e-File system](#).

The e-Filing system will guide you through what you must submit and in what order.

NOTE: All evidence materials/documents must fit USCIS's specified file requirements to ensure successful uploads within the e-File system. Make sure all pictures or scans show the required information clearly. **You must be physically present in the U.S. to file your STEM OPT application.**

- ☐ A new 2 x 2 **passport style photo** taken within the last 30 days;
 - Photos must [meet these requirements](#), and cannot be enhanced or retouched
 - It is recommended that your photos be taken professionally (many pharmacies, copy/print, and shipping stores offer this service).
- ☐ Clear image of your **most current I-94 record** (*you must be physically in the U.S.*);
- ☐ Clear image of your **current EAD** related to your Post-OPT under "Employment Authorization Document;"
- ☐ Clear **image of your passport biographical page(s)** uploaded under section "Employment Authorization Document;"
- ☐ Clear image of **STEM OPT I-20** with your **ORIGINAL** signature on page 1 of the form under "Form I-20;"
- ☐ Clear images of your diploma AND **official** transcripts related to your STEM degree program uploaded under "College Degree;"
Note: If diploma is in Latin, provide translation in this section as well.
- ☐ **Upload the following documents under "Institutional Accreditation"**
 - ☐ Clear image of **HIO Prior Degree Cover Letter** emailed to you as applicant of STEM OPT based on prior degree;
 - ☐ Clear image of **immigration document (ex: Form I-20)** showing CIP Code of prior STEM degree
 - ☐ Clear image of **"Institutional Accreditation" confirmation page**;
 - ☐ Clear image of **"SEVP Certified" School confirmation page**.
- ☐ [USCIS I-765 Filing Fee](#) paid via credit card or direct bank withdrawal at "Review and Submit" section of e-File system. **DO NOT PAY BEFORE APPLICATION IS FULLY COMPLETED AND REVIEWED.** Payment officially submits your application to USCIS.
